## Waiver, Release, and Covenant Not To Sue

I, on my own behalf and on behalf of my heirs, representatives, administrators and assigns, hereby waive and release any and all claimed, demands, causes of action, suits and rights I, or anyone on my behalf, might have against the VCG&HC, its officers and/or directors for personal injury (including death), loss or damage to my property which I (or anyone claiming by or through me) may have against the VCG&HC, its officers and/or directors, as a result of my taking part in the firearms shooting activities sponsored by, sanctioned by, approved by, or located on the premises leased or owned by the VCG&HC, its officers and/or directors. Further, I agree that I will not, nor will anyone acting on my behalf nor I on the behalf of any minor claiming by or through me, bring or maintain any suit in Court to assert any claim against the VCG&HC, its officers and/or directors, for any claim that I might have arising out of my participation in any activities sponsored by, sanctioned by or approved by the VCG&HC, its officers and/or directors.

I UNDERSTAND THAT ENGAGING IN FIREARMS SHOOTING ACTIVITIES CONSTITUTES MY INVOLVEMENT IN A VERY HAZARDOUS AND DANGEROUS ACTIVITY WITH ACCOMPANING RISKS OF PERSONAL INJURY OR DEATH AND LOSS OR DAMAGE TO PERSONAL PROPERTY, AND I HEREBY VOLUNTARILY ASSUME THOSE RISKS.

This instrument shall remain in force and effect indefinitely. I have read and understand the foregoing provisions of this Waiver, Release and Covenant Not to Sue and I have executed this instrument voluntarily on this date
